3. BOWLERS MUST ENTER BOTH SINGLES AND DOUBLES EVENTS.
4. DOUBLES MAY BE EITHER 2 MEN, 2 WOMEN, OR MIXED.
5. CLASSIFICATION FOR DOUBLES EVENT WILL BE BASED ON AVERAGE OF AGE OF TEAM.
6. TWO (2) CLASSIFICATIONS BASED ON AGE.
 - A. CLASS "A" - 65 YEARS AND UP
 - B. CLASS "B" - 55 THRU 64 YEARS
7. AGE AS OF MARCH 27, 2010 WILL BE USED TO DETERMINE CLASSIFICATION.
8.
 - a. BOWLERS WILL USE HIGHEST 2008-2009 ROANOKE YEARBOOK AVERAGE.
 - b. IF NO YEARBOOK AVERAGE USE HIGHEST JAN. 1, 2010 AVERAGE (21 GAMES).
 - c. IF NO AVERAGE BY (a) (b) USE PREVIOUS SUMMER'S AVERAGE(21 GAMES OR MORE).
 - d. ALL OTHERS MUST BOWL SCRATCH (250).
 - e. IF SUBMITTED AVERAGE IS DIFFERENT THAN THE CORRECT AVERAGE, THE BOWLER WILL AUTOMATICALLY BE RECLASSIFIED.
9. HANDICAP WILL BE 90% DIFFERENCE OF BOWLERS ENTERING AVERAGE AND 250.
10. PRIZE MONEY WILL BE RETURNED 100%.
11. PAYOUT 1 PRIZE FOR EVERY 8 ENTRIES FOR EACH EVENT.
12. COMPLETE ENTRY FEES MUST ACCOMPANY ENTRY FORM.
