TOURNAMENT RULES

- 1. USBC TOURNAMENT RULES WILL GOVERN AND ONLY MEMBERS OF GREATER ROANOKE AREA USBC ARE ELIGIBLE. NON MEMBERS LIVING WITHIN THE JURISDICTION OF THIS ASSOCIATION WHO ARE NOT MEMBERS OF ANOTHER ASSOCIATION MAY ENTER BY PAYING UNATTACHED MEMBERSHIP FEE.**
- 2. EARLIEST ENTRIES WILL RECEIVE FIRST CONSIDERATION WITH RESPECT TO PREFERRED SCHEDULE TIME. TEAMS WILL BOWL AS LINED UP ON ENTRY BLANK.**
- 3. TEAM CAPTAINS MUST REPORT TO TOURNAMENT DIRECTOR 30 MINUTES PRIOR TO SQUAD TIME TO MAKE SUBSTITUTIONS. A REPLACEMENT MAY BE MADE IN 'ALL EVENTS' PROVIDING THE REPLACEMENT IS MADE BEFORE THE ORIGINAL ENTRANT OR THE REPLACEMENT HAS BOWLED IN THE TOURNAMENT.**
- 4. ENTRANTS MAY BOWL MORE THAN ONCE IN TEAM EVENT, PROVIDED; (A) NO MORE THAN THREE PLAYERS CAN COMPETE TOGETHER MORE THAN ONCE IN THE TEAM EVENT. FAILURE TO COMPLY WITH THIS RULE DISQUALIFIES TEAM SCORES EXCEPT THE FIRST TEAM ON WHICH THE BOWLERS COMPETED. (B) TEAM RE-ENTRY IS PERMITTED PROVIDED SPARE LANES ARE AVAILABLE, BUT CAN ONLY WIN ONE (1) PRIZE, THAT OF THE HIGHEST VALUE. (C) A BOWLERS PARTICIPATION MORE THAN ONCE IN TEAM EVENT MUST COUNT FIRST SCORE IN "ALL EVENTS".**
- 5. ENTRANTS WILL USE THEIR HIGHEST GREATER ROANOKE AREA USBC CERTIFIED WINTER LEAGUE AVERAGE BASED ON A MINIMUM OF 21 GAMES FOR THE 2011-12 SEASON. IF NO AVERAGE LAST YEAR USE HIGHEST CURRENT GRAUSBC CERTIFIED AVERAGE, 21 GAMES OR MORE, AS OF OCTOBER 20,2012. IF NO WINTER LEAGUE AVERAGE ENTRANT MAY USE HIGHEST 2012 SUMMER LEAGUE AVERAGE BASED ON A MINIMUM OF 21 GAMES. ALL OTHERS MUST BOWL SCRATCH. IF SUBMITTED AVERAGE IS DIFFERENT THAN THE CORRECT AVERAGE, THE BOWLER WILL AUTOMATICALLY BE RECLASSIFIED WITH HANDICAP FOR THE CORRECT AVERAGE. A BOWLER WHO HAS QUALIFIED FOR A PRIZE OF \$300.00 OR MORE IN AN EVENT IN A TOURNAMENT WITHIN USBC RULE 319(E) ARE IN EFFECT.
THE 10 PIN RULE IS NOT IN EFFECT OF THIS TOURNAMENT.**
- 6. ANY AVERAGE SUBMITTED MAY BE RERATED IF TOURNAMENT MANAGEMENT FEELS IT DOES NOT REFLECT THE BOWLERS TRUE ABILITY.**
- 7. DEADLINE FOR ENTRIES IS OCTOBER 20, 2012, ALL ENTRIES POSTMARKED THE FIRST BUSINESS DAY FOLLOWING THE CLOSING DATE SHALL BE ACCEPTED. MAKE CHECKS PAYABLE TO GRAUSBC AND MAIL TO MIKE ECKLES, 7922 LAYNE CT, ROANOKE, VA 24019 BEFORE MIDNIGHT OCTOBER 20, 2012. ALL RETURNED CHECKS WILL BE CHARGED A \$25.00 FEE.**
- 8. TOURNAMENT MANAGER HAS THE RIGHT TO REFUSE ANY ENTRY.**
- 9. DOUBLES AND SINGLES MAY BE BOWLED MORE THAN ONCE, BUT MUST CHANGE PARTNERS FOR DOUBLES, AND ENTRY IN SINGLES AT LEAST ONCE IS REQUIRED TO QUALIFY FOR PRIZES. IF BOWLING MORE THAN ONCE IN ANY EVENT FIRST SCORE WILL BE USED FOR ALL EVENTS. DOUBLES WILL BE BOWLED FIRST, FOLLOWED BY THE SINGLES EVENT.**
- 10. ANY BOWLER OR TEAM ARRIVING LATE SHALL BEGIN PLAY WITH THE SCORE COUNTING BEGINNING WITH THE FRAME THEN BEING BOWLED AND WILL RECEIVE ZERO (0) PINFALL FOR ANY FRAMES MISSED.**
- 11. PROTESTS: ANY PROTESTS AFFECTING ERRORS IN SCORING MUST BE REPORTED TO THE TOURNAMENT DIRECTOR WITHIN TWENTY-FOUR (24) HOURS FROM COMPETITION, AND ALL PROTESTS AFFECTING ELIGIBILITY AND GENERAL PLAYING RULES MUST BE FILED PRIOR TO THE DATE ANNOUNCED FOR PRIZE DISTRIBUTION.**
