**TOURNAMENT RULES**

- 1. USBC TOURNAMENT RULES WILL BE GOVERNED. ALL ENTRANTS MUST BE A MEMBER OF THE GREATER ROANOKE AREA USBC.**
- 2. TEAM CAPTAINS MUST REPORT TO TOURNAMENT OFFICE 30 MINUTES PRIOR TO SQUAD TIME TO MAKE SUBSTITUTIONS, VERIFY AVERAGE, AND SHOW USBC SANCTION CARDS.**
- 3. ENTRANTS MUST USE HIGHEST PREVIOUS SEASON YEARBOOK AVERAGE. IF NO YEARBOOK AVERAGE USE HIGHEST AVERAGE AS OF JAN. 1, 2008. IF NO AVERAGE FROM EITHER OF ABOVE USE HIGHEST PREVIOUS SUMMER AVERAGE. ALL AVERAGES MUST BE FOR 21 OR MORE GAMES. IF AVERAGE OTHER THAN YEARBOOK IS USED, VERIFICATION MUST BE SUBMITTED PRIOR TO BOWLING. ALL OTHERS MUST BOWL SCRATCH (250). THE 10 PIN RULE IS NOT IN EFFECT FOR THIS TOURNAMENT. IF THE SUBMITTED AVERAGE IS DIFFERENT THAN THE CORRECT AVERAGE THE BOWLER WILL AUTOMATICALLY BE RECLASSIFIED WITH THE HANDICAP FOR THE CORRECT AVERAGE.**
- 4. ENTRANTS MAY BOWL MORE THAN ONCE. SAME TWO BOWLERS CAN NOT COMPETE TOGETHER MORE THAN ONCE EXCEPT UNDER RULE #9 BELOW (COMPLETE TEAM RE-ENTRY).**
- 5. BOWLERS MUST ACQUAINT THEMSELVES WITH USBC RULES (319D) & (319E), CONCERNING AVERAGE ADJUSTMENT AND TOURNAMENT WINNINGS IN THE PAST 12 MONTHS.**
- 6. UNMARRIED GRADE OR HIGH SCHOOL STUDENTS UNDER THE AGE OF 18 MUST HAVE WRITTEN CONSENT OF PARENT OR GUARDIAN TO COMPETE. CONSENT MUST BE RECEIVED AT LEAST ONE WEEK PRIOR TO PARTICIPATION UNLESS STUDENT IS ACCOMPANIED BY PARENT OR GUARDIAN, IN WHICH CASE CONSENT MUST BE FILED UPON START OF COMPETITION.**
- 7. CASH PRIZES WILL BE AWARDED ON HANDICAP BASIS ONLY. ONE CASH PRIZE WILL BE AWARDED FOR EVERY EIGHT ENTRIES. PRIZE FEE WILL BE RETURNED 100%.**
- 8. ANY PROTESTS AFFECTING ERRORS IN SCORING MUST BE REPORTED TO THE TOURNAMENT DIRECTOR WITHIN TWENTY-FOUR (24) HOURS FROM COMPETITION, AND ALL PROTESTS AFFECTING ELIGIBILITY AND GENERAL PLAYING RULES MUST BE FILED PRIOR TO THE DATE ANNOUNCED FOR PRIZE DISTRIBUTION.**
- 9. ANY BOWLER ARRIVING LATE WILL BEGIN PLAY WITH SCORE COUNTING BEGINNING WITH FRAME THEN BEING ROLLED, WITH ZERO (0) PINFALL FOR ALL FRAMES MISSED.**
- 10. TEAM MAY RE-ENTER MORE THAN ONCE, RE-ENTRY IS PERMITTED ONLY IF LANES ARE AVAILABLE, BUT CAN ONLY WIN ONE (1) PRIZE, THAT OF THE HIGHEST VALUE.**
