Tournament Rules

- USBC Tournament Rules will govern and to qualify as a participant, all bowlers must be a member of the Greater Roanoke Area USBC (GRAUSBC). Unattached members may enter under the conditions outlined in Rule 300c.
- 2. Entry fees paid by Nov 1 are \$25 per person per event, entries received after Nov 1 or walk-in entries or re-entries are \$30 per person per event.
- 3. Bowlers who enter Singles must also enter Doubles. Bowlers can re-enter but may only cash once in Singles and once in Doubles with the same partner.
- 4. Scratch division is optional in each event at a cost of \$10 per person per event. Bowlers must compete in handicap division to be eligible to enter scratch option in that event.
- 5. Average: All bowlers will use the highest 2022-2023 adult sanctioned average (21 game min), if no 2022-23 adult sanctioned average, then bowlers will use their highest current adult sanctioned average (21 game min) as of November 1, 2023. All others will bowl scratch.
- 6. Handicap: 90% of 230
- 7. The Tournament Director has the discretion to rerate any bowler prior to the start of competition.
- 8. Protests involving any scores must be made before payment of tournament prizes.
- 9. One place paid for every 10 entries in Singles and Doubles.
- 10. Tournament Directors are Michael Shafer and Michelle Martin. Tournament directors are eligible to bowl in the tournament and will decide any questions not covered by USBC tournament rules.
